European Commission Clears Medtronic Acquisition of Covidien

MINNEAPOLIS AND DUBLIN, Ireland Nov. 28, 2014 Medtronic, Inc. (NYSE: MDT) and Covidien plc (NYSE: COV) today announced that the European Commission has conditionally cleared Medtronic's proposed acquisition of Covidien. The clearance decision is conditional on Medtronic's commitment to divest Covidien's drug coated balloon business. As previously announced, a subsidiary of Covidien entered into an agreement to divest Covidien's drug coated balloon business to The Spectranetics Corporation, and the divestiture is expected to close shortly following completion of Medtronic's acquisition of Covidien.

The transaction is expected to close in early 2015 after receipt of certain additional regulatory clearances, approvals by both companies' shareholders and sanction by the High Court of Ireland.
