**Item 8.01 Other Events.**

On May 11, 2015, Virginia Electric and Power Company (the Company) entered into an underwriting agreement (the Underwriting Agreement) with BNP Paribas Securities Corp., J.P. Morgan Securities LLC and Mizuho Securities USA Inc., as Representatives for the underwriters named in the Underwriting Agreement, for the sale of \$350,000,000 aggregate principal amount of the Company's 2015 Series A 3.10% Senior Notes due 2025 and \$350,000,000 aggregate principal amount of the Company's 2015 Series B 4.20% Senior Notes due 2045. Such Senior Notes, which are designated the 2015 Series A 3.10% Senior Notes due 2025 and the 2015 Series B 4.20% Senior Notes due 2045, are Senior Debt Securities that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 under the Securities Act of 1933, as amended, which registration statement became effective on December 19, 2014 (File No. 333-201153). A copy of the Underwriting Agreement, including exhibits thereto, is filed as Exhibit 1.1 to this Form 8-K.

The Twenty-Ninth and Thirtieth Supplemental Indentures to the Company's June 1, 1998 Senior Indenture, as amended, pursuant to which the Senior Notes will be issued, are filed as Exhibits 4.3 and 4.4 to this Form 8-K.
