About this Document

The announcement that ACE has entered into an agreement to acquire Chubb is significant news for both companies and for our industry. We know that the agents and brokers you interact with every day will have questions about this transaction and what it means for them. This document includes key messages/talking points about the announcement so that you will be prepared to respond to their questions.

Please keep in mind:

This document should not be distributed to anyone outside the organization. You may, however, refer to specific talking points in response to questions from brokers and agents.

These messages have been approved by legal counsel and may be filed with the U.S. Securities and Exchange Commission. **Therefore, it is important that you do not add to or alter these materials or any other communications you may receive in the future regarding the combination with Chubb.**

Do not offer your own opinion about the merits of the transaction – it is important that we speak with one voice during this period.

Do not speculate – it is important that we do not introduce rumors or communicate inaccurate information to the marketplace.

The closing of the transaction is subject to approval by ACE and Chubb shareholders, the receipt of regulatory approvals and other customary closing conditions. You should not comment on, or speculate about, this process. The only information you should provide is that the company expects to complete the transaction during the first quarter of 2016.

What We Announced

On July 1, 2015, we announced that ACE entered into a definitive agreement to acquire Chubb, one of the industry's most well respected P&C companies with outstanding people, products, customer service and a world-class agency model.

We are combining two great companies to create a global leader in property and casualty insurance. When the transaction is complete, the combined company will be the second largest commercial lines insurer in the U.S. and the fourth largest global insurer by book value.

Our companies share a great mutual respect and have complementary and exceptional strengths in product, distribution, customer segments and underwriting cultures.

The combined company will be even better positioned to serve commercial customers of all sizes – from the largest corporations with complex multinational exposures to the middle market and small commercial companies.

What This Means for Our Distribution Partners

ACE and Chubb are two great underwriting companies that share a passion for product innovation and outstanding client and agent service.

For distribution partners like you, this combination means enhanced product offerings backed by substantial financial strength and security for your clients.
