This Amendment No. 2 to Schedule 13D (this <u>Amendment No. 2</u>) is filed by Kirby Enterprises Inc. (the <u>Reporting Person</u>) with respect to ownership of the ordinary shares, NIS 15.00 par value per share (the <u>Ordinary Shares</u>), of Tower Semiconductor Ltd., a company organized under the laws of the State of Israel (the <u>Issuer or Tower</u>), and amends and supplements the Schedule 13D filed on July 29, 2015 (the <u>Original Schedule 13D</u>) and Amendment No. 1 to Schedule 13D filed on January 11, 2016 (<u>Amendment No. 1</u> and, together with the Original Schedule 13D and this Amendment No. 2, the <u>Schedule 13D</u>). Capitalized terms used herein and not otherwise defined in this Amendment No. 2 shall have the meanings set forth in the Original Schedule 13D.

The amendments to the Schedule 13D included herein reflect the sale of 1,684,285 Ordinary Shares by the Reporting Person, which sale occurred on March 8, 2016 in a transaction conducted in accordance with the requirements of Rule 144 under the Securities Act of 1933, as amended (<u>Rule 144</u>). The trade is expected to settle on March 11, 2016.

Accordingly, this Amendment No. 2 amends Item 5 of the Schedule 13D as follows:

Item 5. Interest in Securities of the Issuer

Items 5(a) (c) of the Schedule 13D is amended and restated as follows:

- (a) After giving effect to the sale on March 8, 2016, the Reporting Person is the beneficial owner of 6,664,175 Ordinary Shares, constituting approximately 7.7% of Tower s outstanding Ordinary Shares, based on 86,034,168 Ordinary Shares outstanding as of March 8, 2016 (the number of Ordinary Shares outstanding on March 8, 2016, as reported by Tower to the TASE), and calculated in accordance with Rule 13d-3(d)(1)(i). The above number of outstanding Ordinary Shares does not include 86,667 treasury shares of Tower.
- (b) After giving effect to the sale on March 8, 2016, the Reporting Person has sole voting and dispositive power over the 6,664,175 Ordinary Shares beneficially owned by it.
- (c) On a trade date of March 8, 2016, the Reporting Person sold 1,684,285 Ordinary Shares at \$13.00 per Ordinary Share in a privately negotiated transaction in accordance with Rule 144. The trade is expected to settle on March 11, 2016. Except as set forth above, neither the Reporting Person, nor, to the best of its knowledge, any of its directors or

executive officers, has effected any transaction in any securities of Tower during the past sixty (60) days.
