(1) Pursuant to the Share Purchase Agreement, dated as of May 17, 2018, by and among PayPal Holdings, Inc. (the Company) and the sellers named therein (as amended, the Share Purchase Agreement), the Company assumed certain outstanding unvested options to purchase ordinary shares of iZettle AB (publ) (iZettle) granted under the Terms and Conditions Governing Employee Stock Options 2013/2019, Terms and Conditions Governing Employee Stock Options 2017/2023 and Terms and Conditions Governing Employee Stock Options 2018/2024 in iZettle (collectively, the Plans), subject to their respective continued vesting schedules and conditions. The assumed options became exercisable solely to purchase shares of common stock of the Company, with appropriate adjustments to the number of shares into which the assumed options are exercisable and the exercise price of such options in accordance with the terms of the Share Purchase Agreement.

Pursuant to Rule 416(a) under the Securities Act of 1933, as amended (the Securities Act), this Registration Statement shall also cover any additional shares of common stock of the Company that become issuable under the Plans by reason of any stock dividend, stock split, recapitalization or other similar transaction effected without the receipt of consideration that results in an increase or decrease in the number of outstanding shares of the common stock of the Company.

EXPLANATORY NOTE

This Registration Statement on Form S-8 is filed by PayPal Holdings, Inc. (the Company) in connection with that certain Share Purchase Agreement, dated as of May 17, 2018 (as amended, the Share Purchase Agreement), by and among the Company and the sellers named therein regarding all shares, warrants and options in iZettle AB (publ) (iZettle). Pursuant to the Share Purchase Agreement, on September 20, 2018 (the Effective Time), the Company purchased all of the issued and outstanding capital stock held by the shareholders of iZettle. Under the Share Purchase Agreement, each in-the-money unvested option held by an individual who is an employee of iZettle immediately following the Effective Time to purchase iZettle ordinary shares granted under the Terms and Conditions Governing Employee Stock Options 2013/2019, Terms and Conditions Governing Employee Stock Options 2017/2023 and Terms and Conditions Governing Employee Stock Options 2018/2024 (collectively, the Plans) that was outstanding and unexercised immediately prior to the Effective Time was assumed by the Company and converted into an option to purchase shares of common stock of the Company, on the same terms and conditions (including vesting and exercisability) as the iZettle stock option, except the number of shares of Company common stock subject to each such converted iZettle stock option equals (a) the number of ordinary shares of iZettle subject to each such iZettle stock option, multiplied by (b) the conversion ratio (as defined below), rounded down to the nearest whole share of Company common stock; the per share exercise price for each such converted iZettle stock option equals (i) the per share exercise price applicable to each such iZettle stock option divided by (ii) the conversion ratio, rounded up to the nearest whole cent; and for certain administrative and other changes required for consistency with the Company's equity compensation plan. The conversion ratio is equal to 0.2165, which equals the fraction (rounded to the nearest 1/10,000) obtained by dividing \$19.57 by the average closing price of a share of Company common stock as reported on the NASDAQ Global Select Market for the period of 10 consecutive trading days ending on (and including) the second trading day prior to the Effective Time. The agreed upon exchange rate is 8.90 SEK for \$1.00. This Registration Statement relates to the 88,821 shares of Company common stock issuable pursuant to such converted iZettle stock options outstanding as of September 20, 2018 under the Plans. On October 18, 2018, the last reported sale price for our common stock on the NASDAQ Stock Market was \$77.48 per share.

(3) The description of the Company's capital stock contained in the Company's registration statement on Form 10 filed with the Commission under Section 12(b) of the Securities Exchange Act of 1934, as amended, on February 25, 2015, as amended by Amendment No. 1 filed on April 9, 2015, Amendment No. 2 filed on May 14, 2015, Amendment No. 3 filed on June 2, 2015, Amendment No. 4 filed on June 18, 2015 and Amendment No. 5 filed on June 26, 2015.

All other documents subsequently filed by the Company pursuant to Sections 13(a), 13(c), 14 and 15(d) of the Securities Exchange Act of 1934 (the Exchange Act), prior to the filing of a post-effective amendment which indicates that all securities offered have been sold or which deregisters all securities then remaining unsold, shall be deemed to be incorporated by reference in this Registration Statement and to be a part hereof from the date of the filing of such documents.

Notwithstanding the foregoing provisions of this Item 3, no document, or portion of or exhibit to a document, that is furnished to (rather than filed with) the Commission shall be incorporated or deemed to be incorporated by reference in this Registration Statement.

As permitted by Section 145 of the Delaware General Corporation Law (the DGCL), the Company's Amended and Restated Bylaws (the Bylaws) provide that (i) the Company is required to indemnify its directors and officers to the fullest extent permitted by the DGCL; provided, however, that the Company is required to provide indemnification with respect to a proceeding (or part thereof) initiated by one of such persons only if the proceeding (or part thereof) is authorized by the Company's board of directors, (ii) the Company may, in its discretion, indemnify other persons as set forth in the DGCL, (iii) to the fullest extent permitted by the DGCL, the Company is required to advance all expenses incurred by its directors and officers in connection with a legal proceeding (subject to certain exceptions), (iv) the rights conferred in the Bylaws are not exclusive, (v) the Company is authorized to enter into indemnification agreements with its directors, officers, employees and agents and (vi) the Company may not retroactively amend the Bylaws provisions relating to indemnity.

The Company has entered into agreements with its directors and executive officers that require the Company to indemnify such persons against expenses, judgments, fines and other amounts that such person becomes legally obligated to pay (including expenses of a derivative action) in connection with any proceeding, whether actual, pending, completed or threatened, to which any such person may be made a party by reason of the fact that such person is or was a director or officer of the Company or any of its affiliated enterprises, provided such person acted in good faith and in a manner such person reasonably believed to be in or not opposed to the best interests of the Company. The indemnification agreements also set forth certain procedures that will apply in the event of a claim for indemnification thereunder.

provided, however, that paragraphs (a)(i) and (a)(ii) do not apply if the information required to be included in a post-effective amendment by those paragraphs is contained in reports filed with or furnished to the Commission by the registrant pursuant to Section 13 or Section 15(d) of the Exchange Act that are incorporated by reference herein.

(b) That, for the purpose of determining any liability under the Securities Act, each such post-effective amendment shall be deemed to be a new registration statement relating to the securities offered therein, and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof.

(c) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering.

2. The undersigned registrant hereby undertakes that, for purposes of determining any liability under the Securities Act, each filing of the registrant's annual report pursuant to Section 13(a) or Section 15(d) of the Exchange Act (and, where applicable, each filing of an employee benefit plan's annual report pursuant to Section 15(d) of the Exchange Act) that is incorporated by reference in the Registration Statement shall be deemed to be a new registration statement relating to the securities offered herein, and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof.

3. In the event that a claim for indemnification against such liabilities (other than the payment by the registrant of expenses incurred or paid by a director, officer or controlling person of the registrant in the successful defense of any action, suit or proceeding) is asserted by such director, officer or controlling person in connection with the securities being registered, the registrant will, unless in the opinion of its counsel the matter has been settled by controlling precedent, submit to a court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Securities Act and will be governed by the final adjudication of such issue.
