Today's news that IBM has agreed to acquire all Red Hat outstanding shares in a deal where we would become an independent unit within IBM validates your decades of leadership in the community, dedication to the needs of our customers, focus on partner ecosystems, and commitment to building the industry's broadest, highest quality, and most successful open source portfolio.

Even with this change, our mission remains unaltered and is now more important than ever. Our three pillars of hybrid cloud infrastructure, cloud-native application development, and management and automation are at the core of why IBM is making the largest acquisition of any software company to date.
