Item 1.

Security and Issuer

This Schedule 13D is being filed jointly on behalf of Christopher Bunka, C.A.B. Financial Services Ltd., and 0743608 B.C. Ltd, (together the "Reporting Persons") relating to the shares of common stock, par value \$0.001 ("Common Stock") of Golden Aria Corp., a corporation formed under the laws of the State of Nevada (the "Issuer"). The principal executive office of the Issuer is 483 Holbrook Rd E, Kelowna BC Canada V1X 7H9.

Purpose of Transaction
