The option purchase price was paid in accordance with the 2002 Plan in the form of 4,553 shares valued in accordance with the 2002 Plan. In addition, 2,270 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant. As a result of the transactions reported herein, the reporting person's direct ownership of common shares increased by 4,777 shares.
