- (1) I received a distribution of formerly restricted shares of stock and made an advance election to satisfy my tax payment obligations by selling shares to Questar.
- (2) The shares vest in three annual installments, beginning one year from date of grant on February 12, 2009. The shares were awarded under the terms of Questar's Long-term Stock Incentive Plan.
- (3) As of February 11, 2008, I have 47,937.5849 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.
- (4) Phantom stock units will be converted to cash per my elections on or within 5 years of my termination of employment (subject to 6-month delay if necessary to comply with IRC 409A), or upon my death or Disability.
- (5) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 8,300.6396 units in such plan in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
