- (1) grant. The aggregate performance RSU's were originally awarded on December 9, 2009. The second year performance criteria were met on December 9, 2011 and the RSU's vested as to 1/3 of the original award. Each RSU represents a right to receive one share of Winn-Dixie Stores, Inc. common stock.
- (2) Shares sold to satisfy tax withholding obligations that became due upon the vesting of RSUs.
- The price shown is the weighted average price at which shares were sold in multiple sales transactions made pursuant to a single market
