- Represents shares of performance based restricted stock units granted to the filing person on January 11, 2011. The restricted stock units vest over three years

Of the 12,745 shares of common stock, 4,248 shares were issued on February 08, 2012, of which 1,761 shares were withheld to satisfy payment of the Issuer's tax withholding obligation.
