- (1) The shares are represented by units held in a unitized stock fund through the Issuer's 401(k) Retirement Plan and Trust. The unitized stock fund of the Issuer's 401(k) Retirement Plan and Trust consists of cash and Common Stock in amounts that vary from time to time. As of March 31, 2012, the reporting person had 3,071 units in the Issuer's 401(k) Retirement Plan and Trust, which units consisted of 2,454 shares of Common Stock.
- (2) The option, representing the right to purchase a total of 10,000 shares, becomes exercisable in two equal installments of 5,000. The first such installment occurred on December 14, 2011, which was the fourth anniversary of the date on which the option was granted, and the second such installment occurs on December 14, 2012, which is the fifth anniversary of the date on which the option was granted.
- (3) The option becomes exercisable in five equal annual installments beginning on December 10, 2010, which was the first anniversary of the date on which the option was granted.
