Also includes 6,250 shares of common stock granted as restricted stock, restrictions lapse in equal quarterly installments of 1,250 shares with the next vesting on December 31, 2013 with the final installment on December 31, 2014 and 8,666 shares of common stock granted as restricted stock, restrictions lapse in equal installments of 962 shares vesting quarterly, with the next vesting on December 31, 2013 and thereafter equal installments on March 31, June 30, September 30 and December 31 of each year with the final 970 shares on December 31, 2015.
