(1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. These shares were not sold by the Reporting Person but were instead offset from the total number of vested shares received by the Reporting Person from the Issuer.

(2) The restricted stock unit was granted to Richard A. Baldrige, an employee of ViaSat, Inc. Upon vesting the shares were contributed to The Baldrige Family Trust.

(3) Includes 218 shares of common stock the reporting person acquired under the ViaSat 401(k)Plan, since the date of the reporting person's last ownership report.

(4) The original restricted stock unit grant was for 20,567 restricted stock units on 11/12/2012. (5) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
