(1) As previously reported, on October 1, 2013, the reporting person received a grant of 60,431 restricted stock units that vest in one-third increments on each of the first, second and third anniversaries of the date of grant. The second anniversary occurred on October 1, 2015, resulting in the vesting and settlement of 20,144 shares of common stock, as shown in Table I. The remaining 20,144 restricted stock units are shown in Table II, which are scheduled to vest on October 1, 2016.

(2) Restricted stock units convert into common stock on a one-for-one basis.

(3) Shares withheld for payment of taxes upon vesting of restricted stock units in accordance with Rule 16b-3.
