Restricted Stock Units (RSUs) issued in lieu of the additional pro rata 2018 annual retainer and meeting fees of \$5,694.44. The RSUs vest

(1) on a quarterly basis on the last day of each calendar quarter and are pro rated for the second quarter of 2018 and thereafter vest ratably for the last two remaining calendar quarters in 2018, subject to the reporting person's continuous service to Regulus.

(2) The option will vest in twelve equally monthly installments, such that the option will be fully vested one year from the date of grant, or the date of the Company's 2019 annual shareholder meeting, whichever occurs first.
