The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (3) The aggregate of 17,393.25 phantom stock units includes (a) 64.63 phantom stock units acquired through dividend reinvestment in the Harris Corporation Directors' Deferred Compensation Plans ("Plans") on 5/31/18 and (b) a reduction of a .07 phantom stock unit due to rounding of previous reports by the Plans' recordkeeper.
