The original option was previously amended on May 16, 2014 to extend the expiration date from January 4, 2015 to January 4, 2017.

The SAR was originally granted on March 16, 2011 and fully vested when the Company completed repurchase transactions of its common stock aggregating \$1.5 million in equivalent value.
