This statement is filed pursuant to Rule 13d-2(b) with respect to the common stock ("Common Stock") of Labor Smart, Inc. beneficially owned by the Reporting Persons specified herein as of February 13, 2015 and amends and supplements the Schedule 13G dated as of and filed on October 27, 2014 ("Schedule 13G"). (a) Amount Beneficially Owned: 94,210,043* shares of Common Stock as of February 13, 2015

(b) Percent of Class: 9.99%*

The Reporting Persons' beneficial ownership of 94,210,043* shares of Common Stock constitutes 9.99%* of all the outstanding shares of Common Stock, based upon 848,833,428 shares of Common Stock outstanding as of January 28, 2015, as reported by the Issuer in its most recent Form 8-K.

(c) Number of shares as to which such person has:

(i) sole power to vote or to direct the vote: 0

(ii) shared power to vote or to direct the vote: 94,210,043*

(iii) sole power to dispose or to direct the disposition of: 0

(iv) shared power to dispose or to direct the disposition of: 94,210,043*

*The Reporting Persons may be deemed to beneficially own a 10% OID Convertible Note Due January 1, 2015 ("Note") issued to Gemini Master Fund, Ltd. ("Gemini"), which has an outstanding principal amount of \$175,000.00 and which is convertible into shares of Common Stock ("Conversion Shares").

In accordance with Rule 13d-4 under the Securities Exchange Act of 1934, as amended, because the number of shares of Common Stock into which the Note is convertible is limited, pursuant to the terms of such instrument, to that number of shares of Common Stock which would result in the Reporting Persons having beneficial ownership of 9.99% of the total issued and outstanding shares of Common Stock (the "Ownership Limitation"), the Reporting Persons disclaim beneficial ownership of any and all shares of Common Stock that would cause any Reporting Person's beneficial ownership to exceed the Ownership Limitation. Therefore, in accordance with the Ownership Limitation, each of the Reporting Persons disclaims beneficial ownership of any Conversion Shares to the extent such shares would cause the Ownership Limitation to be exceeded.

In addition, as permitted by Rule 13d-4, the filing of this statement shall not be construed as an admission that Gemini Strategies LLC, Inc., in its capacity as investment manager for Gemini, is the beneficial owner of the Conversion Shares or the Note or that Steven Winters, in his capacity as president or principal of Gemini Strategies LLC, Inc., is the beneficial owner of the Conversion Shares or the Note. Each of Gemini Strategies LLC, Inc. and Steven Winters expressly disclaims any equitable or beneficial ownership of the Conversion Shares and the Note.
