(1) The amended Form 4 is being filed to correctly disclose that the number of shares that were acquired from the exercise of stock options were acquired from two stock option grants rather than one. The original Form 4 incorrectly disclosed that the shares were acquired entirely from the exercise of stock options granted on 11/17/2000, whereas the shares were actually acquired from two separate stock options, one granted on 11/17/2000 and one granted on 11/15/2001.
