- (1) On 5/10/2005, the issuer ("ADC") undertook a reverse 1-for-7 split of its common stock and on July 1, 2005, ADC terminated its Global Employee Stock Purchase Plan ("GESPP"). The reporting person's beneficial direct holdings, previously reported as 83,616 shares, have been adjusted to reflect the reverse split and termination of GESPP. The reporting person previously reported indirect beneficial ownership of 37,712 shares through the GESPP. The reporting person's GESPP holdings have been adjusted to reflect the split and added to the reporting person's previously reported direct beneficial holdings. The reporting person also indirectly beneficially owns 5,306 shares through the ADC Telecommunications, Inc. Retirement Savings Plan (401k) ("ADC 401k") based on a plan statement dated as of 9/30/05. The reporting person's holdings through the ADC 401k had previously been reported as 27,474 shares, but have been adjusted to reflect the split.
