- (1) Represents the conversion upon vesting of restricted stock units ("RSUs") into common stock. - (5) Each RSU is the economic equivalent of one share of S&W Seed Company common stock. The closing price of SANW on July 1, 2015 was \$4.72.

On March 16, 2013, the reporting person was granted 100,000 RSUs, of which 4,722 vested on July 1, 2015. The common stock into which such vested restricted stock units converted on July 1, 2015 is reported on Table I of this Form 4. The remaining unvested RSUs

- (6) will continue to vest in 9 additional quarterly installments of 4,722 RSUs on the first day of each fiscal quarter and a final quarterly installment will vest an aggregate of 4,726 RSUs on October 1, 2017. Vested shares will be delivered to the reporting person on the settlement date unless the Issuer elects to settle the RSUs in cash or a combination of shares and cash, at the Issuer's discretion.
