(1)Cassa Depositi e Prestiti is a state-controlled company, with the Republic of Italy (acting through the Ministry of Economy and Finance) owning 70% of the outstanding share capital. The residual 30% is owned by 65 Italian Banking Foundations. In comparison with schedule 13G filed on December 22, 2003 (from which it turned out that the company was wholly owned by the Republic of Italy), Cassa Depositi e prestiti ownership breakdown has changed, having the Ministry of Economy and Finance sold the 30% of the share capital to the banking foundations.

(2)Pursuant to the provisions set forth in art. 9 of the Decree issued on December 5, 2003 by the Italian Ministry of Economy and Finance, effective on December 12, 2003, the Republic of Italy transferred to Cassa depositi e prestiti n. 400,288,338 ENI ordinary shares. In comparison with last year, the percentage of ownership has slightly decreased (passing from 9.999% to 9.996%), as a consequence of the increase of ENI number of shares, due to the exercise of stock options.
