Item 4. Ownership.

The total aggregate amount of issuer's securities owned by filer is 249,600 shares, which represents 7.3% of the issued class. Of these shares, 222,400 are owned by clients of Sterling Capital Management, a registered investment adviser, which has a beneficial interest in the shares by virtue of its discretion over, and shared power to dispose of, the shares. Sterling Capital Management also shares with a client the power to vote 3,500 of these 222,400 shares. 15,000 of the total aggregate shares are owned in an individual capacity or as Custodian by William G. Lauber, President of Sterling Capital Management, who has sole power to vote and dispose of these shares. 1,600 shares of the total aggregate shares are owned by William G. Lauber & his wife jointly. Mr. Lauber has shared power to vote and dispose of these shares. Of the 249,600 shares, Sterling Capital Management employees (other than William G. Lauber) own 10,600 shares, of which Mr. Lauber disclaims beneficial ownership.
