**MINUTES OF THE 537th MEETING OF THE BOARD OF DIRECTORS**

**HELD ON DECEMBER 13, 2007**

On December 13, 2007, at 9:00 (nine) a.m., at the Company's offices located at Avenida das Nações Unidas, 4.777, in the City of São Paulo, State of São Paulo, CEP 05.477 -000, the five hundred and thirty-seventh (537<sup>th</sup>) Meeting of the Board of Directors of **BRASKEM S.A.** was held with the presence of the undersigned Board Members. The Board Members Alvaro Pereira Novis and Patrick Horbach Fairon, as well as the respective alternates, did not attend the Meeting, and were replaced, respectively, by Board Members Ruy Lemos Sampaio and Edmundo José Correia Aires, according to the representation letters previously submitted in compliance with the procedure set out in the Bylaws of the Company. The Board Member Luiz Fernando Cirne Lima and his respective alternate were also absent. The Chief Executive Officer José Carlos Grubisich, and Officers Carlos Fadigas and Mauricio Ferro, as well as Mr. Nelson Raso and Ms. Marcella Menezes Fagundes, were also present at the Meeting. The Chairman of the Board of Directors, Pedro Augusto Ribeiro Novis, presided the meeting and Ms. Marcella Menezes Fagundes acted as secretary.

( Petroflex ),** so as to approve the disposal of the Company's ownership interest in the capital of Petroflex, according to the value and other conditions set out in the Annex to the respective PD, authorizing the Executive Committee to perform the acts required to implement such disposal; **II) Subjects for Acknowledgment:** Nothing to register. **III) Subjects of Interest of the Company:** Nothing to register. **IV) Adjournment-** As there were no further subjects to be discussed, these minutes were drawn up, which, after read, discussed and found to be in order, are signed by all the Board Members present at the meeting, by the Chairman and by the Secretary.
