**GOL is ranked first in punctuality in April and year-to-date**

**São Paulo, May 5, 2015 – GOL Linhas Aéreas Inteligentes S.A. (BM&FBOVESPA: GOLL4 and NYSE: GOL), (S&P: B, Fitch: B-, Moody's: B3),** the largest low-cost and best-fare airline in Latin America, hereby announces to its shareholders and the market in general that it was ranked first in punctuality in April, with 96.82%, according to Infraero's figures for the domestic market, with more than 22,000 domestic flights in the period.

This result reinforces the Company's commitment to maintain and improve such index, one of the extremely relevant factors for customers' satisfaction and preference. Year-to-date, GOL recorded punctuality of 94.79%, in line with the leadership seen in March.

In addition, the Company strongly invests in several initiatives to increase satisfaction and to improve customers' travel experience, such as resources and service tools in order to facilitate and ensure greater agility and convenience for customers. For instance, the geolocation technology, available in mobile apps. Via mobile phone, customer receives notices about estimated time, indicating the possibility of anticipating or postponing the flight. Already two months operating, more than 144,000 downloads were recorded and over 22,000 passengers anticipated or postponed their flights through this service.
