**Item 8.01 Other Events.**

On August 31, 2007, National Fuel Gas Company (the "Company") issued a press release regarding the completion by its Exploration and Production unit, Seneca Resources Corporation ("Seneca"), of its sale of its Canadian subsidiary, Seneca Energy Canada Inc.
