**Item 7.01 Regulation FD Disclosure.**

On July 28, 2011, Arbitron Inc. (the "Company") announced it had acquired Zokem Oy, and issued a press release announcing, among other things, that the consideration included payment of approximately \$11.7 million in cash at closing with possible additional incremental cash payments through 2014 of up to \$12 million based on future financial performance.

The Company is filing this Form 8-K/A to clarify that the up to \$12 million in possible additional incremental cash payments could be paid through 2015 based on future financial performance.
