ITEM 2.02. Results of Operations and Financial Condition.

On October 25, 2017, Las Vegas Sands Corp. (the “Company”) announced its financial results and certain other information for the fiscal quarter ended September 30, 2017 on a press release (the “Earnings Release”). The Earnings Release was included as Exhibit 99.1 to the Company’s Current Report on Form 8-K furnished to the Securities and Exchange Commission on October 25, 2017.

The Earnings Release incorrectly referenced the first quarter of 2014 instead of the fourth quarter of 2014 in the following sentence: “That strong gaming performance, coupled with higher hotel occupancy and retail mall revenues, helped drive an adjusted property EBITDA performance of \$652 million, our best quarterly result since the first quarter of 2014.” The Company is hereby amending and restating that sentence in the Earnings Release to correctly state: “That strong gaming performance, coupled with higher hotel occupancy and retail mall revenues, helped drive an adjusted property EBITDA performance of \$652 million, our best quarterly result since the fourth quarter of 2014.” Except as described in this paragraph, no other revisions are being made to the Earnings Release pursuant to this Current Report on Form 8-K/A.
