As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 1,319,800 shares of the Company's Common Stock and Millenco LLC, a Delaware limited liability company ("Millenco"), is the beneficial owner of 214,400 shares of the Company's Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the manager of Millenco, and may be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities beneficially owned by Integrated Core Strategies and/or Millenco. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies and/or Millenco.

(b) Percent of Class:

Millennium Management and Mr. Englander may be deemed to beneficially own 1,534,200 shares or 4.1% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 37,399,499 shares of Common Stock outstanding as of August 10, 2009, as per the Company's Prospectus Supplement dated August 4, 2009 and the Company's press release dated August 10, 2009.
