Aetos Corporation, a Tortola, British Virgin Islands corporation for which ASB acts as investment adviser, may be deemed to beneficially own 718,251 of these 1,300,000 shares, which equates to 5.18% of the Common Stock. Aetos Corporation acquired more than 5% of the common stock on December 1, 2006.
