According to the Plan of Liquidation, Mr. Eric Slifka received 650,000 Common Units.

Prior to March 23, 2015, Mr. Richard Slifka, Mr. Eric Slifka and the Estate of Mr. Alfred Slifka shared voting and investment power with respect to Common Units owned by AEHC and, therefore, were deemed to beneficially own the Common Units held by AEHC. On

- (3) March 23, 2015, when the Common Units then held by AEHC were distributed to AEHC's stockholders pursuant to the Plan of Liquidation, Mr. Richard Slifka, Mr. Eric Slifka and the Estate of Alfred Slifka ceased to exercise share voting and investment power over Common Units owned by AEHC.
