Item 8.01 Other Events.

On February 19, 2014, Ascent Solar Technologies, Inc., a Delaware corporation (the “ Company ”), entered into a securities purchase agreement (the “ Purchase Agreement ”) with one institutional and accredited investor (the “ Investor ”). Pursuant to the terms of the Purchase Agreement, the Company will sell to the Investor (i) \$2,500,000 (2,500 shares) of Series D-1 Convertible Preferred Stock (the “ Series D-1 Preferred Stock ”), and (ii) warrants (the “ Warrants ”) to purchase up to 541,126 shares of the Company’s common stock, par value \$0.0001 per share (the “ Common Stock ”). The Series D-1 Preferred Stock will be offered and sold pursuant to a prospectus supplement dated February 23, 2015 filed with the Securities and Exchange Commission in connection with the Company’s shelf registration statement on Form S-3 (File No. 333-199214), which became effective on October 16, 2014. The Warrants have been privately placed in reliance upon exemptions from the registration requirements under Section 4(a)(2) under the Securities Act of 1933, as amended (“ Securities Act ”), and Rule 506 of Regulation D promulgated thereunder.

This Form 8-K provides as an exhibit the unqualified legal opinion in connection with the prospectus supplement and the shelf offering referred to above.
