- On December 31, 2011, 66,667 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit
- (1) award agreement, he elected to have the Company withhold 31,121 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
