Mr. McDonald's 2013 Annual Incentive and 2011-2013 Long-term Incentive awards were paid 50% in cash (paid in March 2014) and 50% in equity (76,689 shares). The portion paid in equity was in the form of restricted stock that had a vesting date of August 26, 2014.

(1) The restrictions have lapsed on the restricted stock. Mr. McDonald elected to have Hecla Mining Company withhold 38,176 shares to cover his tax liability.

(2) Dividend shares accrued on the 76,689 restricted shares that vested.
