- (1) This transaction appeared on Mr. Foster's original Form 4 filed April 3, 2008 and reflects a distribution of shares according to the insider's election under the issuer's Executive Voluntary Deferral Plan, with fractional shares paid in cash. However, the Form 4 filed on April 3, 2008 also showed a non-open market disposition of 95 shares. This disposition did not occur and was inadvertently reported. Mr. Foster's non-derivative holdings as of April 3, 2008 are as shown on this amended Form 4 at 15,575 shares.
