219,379 of the Reported Shares are held by the Hodges Pure Contrarian Fund which is in a series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to this fund is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
