The Adviser, in its capacity as the investment manager of the Funds, has the power to vote and the power to direct the disposition of all Shares held by the Funds. Accordingly, for the purposes of Reg. Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 3,372,674 Shares, or 3.43% of Shares deemed issued and outstanding as of October 31, 2017. Roderick Wong is the Managing Partner of the Adviser. The beneficial ownership percentage reported herein is based on 98,404,761 voting Shares

issued and outstanding as of October 31, 2017, as disclosed in the Company's Quarterly Report for the quarter ended September 30, 2017, as filed with the Securities and Exchange Commission on November 8, 2017.
