(1) Represents shares of common stock acquired upon vesting of certain performance-based share units as a result of achievement of performance goals.

Under the exchange program, the vested portion of the eligible stock options as of the grant date of the replacement stock options were exchanged for stock options that were fully vested. The unvested portion of the exchanged stock options were exchanged for unvested replacement stock options that vest and become exercisable over a period of time that is equal to the remaining vesting period of the exchanged stock options, plus one year, subject to the participant's continued employment through the new vesting date.

(5) This option is a replacement stock option and the remaining unvested portion vests in four equal installments beginning on October 25, 2010.

(6) This stock option vests in four equal annual installments beginning on February 26, 2014.
