Item 1. Security and Issuer

This Amendment No. 4 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated December 10, 2013 and filed with the SEC on December 12, 2013 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated July 1, 2016 and filed with the SEC on July 6, 2016 ("Amendment No. 1"), as further amended by Amendment No. 2 dated September 12, 2016 and filed with the SEC on September 14, 2016 ("Amendment No. 2"), as further amended by Amendment No. 3 dated October 3, 2016 and filed with the SEC on October 6, 2016 ("Amendment No. 3"), for Bank of America Corporation ("BAC"), Banc of America Preferred Funding Corporation ("BAPFC"), and Blue Ridge Investments, L.L.C. ("Blue Ridge") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") of Nuveen Quality Municipal Income Fund (the "Issuer") formerly known as Nuveen Dividend Advantage Municipal Fund.

This Amendment is being filed as a result of the transfer by Blue Ridge of 306 VMTP Shares (CUSIP No. 67066V820), representing all the VMTP Shares owned by Blue Ridge, to BAPFC (the "Transfer"). Prior to the Transfer BAPFC held 5,149 VMTP Shares and following the transfer BAPFC holds 5,455 VMTP Shares, representing all the VMTP Shares of the Issuer.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof: "BAPFC purchased from Blue Ridge 306 variable rate munifund term preferred shares (CUSIP No. 67066V820) (the "Transfer").

The aggregate amount of funds used by BAPFC for the Purchase was approximately \$30,600,000. The source of funds was the working capital of BAPFC."

Item 4. Purpose of Transaction

Item 4 of the Original Schedule 13D is hereby amended by adding the following paragraph at the end thereof: "BAPFC made the Purchase of 306 VMTP Shares (CUSIP No. 67066V820) from Blue Ridge for investment purposes. BAPFC acquired the 306 VMTP Shares (CUSIP No. 67066V820) from Blue Ridge pursuant to a Purchase and Assignment Agreement, dated November 29, 2018, between the BAPFC and Blue Ridge (the "Purchase Agreement") for a purchase price of \$30,600,000.

The Reporting Persons have not acquired the subject securities with any purpose, or with the effect of,

changing or influencing control of the Issuer, or in connection with or as a participant in any transaction having that purpose or effect."
