(1) The 150 preferred shares reported as disposed of in Table I represent variable rate munifund term preferred shares (the "VMTP Shares") that were beneficially owned by Banc of America Preferred Funding Corporation ("PFC"). The VMTP Shares were disposed of as a result of a redemption by the Issuer for a redemption price of \$103,254.79 per share (which includes a liquidation preference of \$100,000.00 per share and accrued dividends of 3,254.79 per share). PFC is a wholly owned subsidiary of Bank of America Corporation.
