- Effective September 13, 2016, the reporting person received a target number of 19,988 performance stock units ("PSU"). Each PSU represents a contingent right to receive one share of the Issuer's common stock and will vest upon the achievements of certain
- (1) performance levels based on the Issuer's (i) return on invested capital, as measured from January 1, 2016 to December 31, 2018, and (ii) annual compound total shareholder return, as measured from August 22, 2016 to March 15, 2019. The number of shares reported in column 3 may range from zero to a maximum number of 49,970 shares.
  - (2) Effective September 13, 2016, the reporting person received 9,845 restricted stock units ("RSU"). Each RSU represents a contingent right to receive one share of the Issuer's common stock and will vest on August 22, 2019, subject to continuous service.
  - (3) Effective September 13, 2016, the reporting person received 23,866 additional RSUs, of which 17,900 will vest on March 31, 2017 and 5,966 will vest on March 31, 2018, in each case subject to continuous service. Each RSU represents a contingent right to receive one share of the Issuer's common stock.
