- (2) Restricted Stock Unit ("RSU") granted under the NIKE, Inc. Stock Incentive Plan. All of the RSUs shall vest 100% with respect to the total number of RSUs on the third anniversary of the Grant Date; and upon any termination of employment, any units that have not vested
