This represents the difference between the number of SARs exercised (2,000) and the number of shares issued as a result of the exercise (477). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$67.28) and the exercise price (\$41.82). Additional shares are then withheld to satisfy the Company's tax withholding obligations.
- (1) This represents the difference between the number of SARs exercised (4,000) and the number of shares issued as a result of the exercise (1,156). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$67.28) and the exercise price (\$36.41). Additional shares are then withheld to satisfy the Company's tax withholding obligations.
