(1) On December 22, 2008, the reporting person was granted a stock appreciation right in respect of an aggregate of 150,000 shares of common stock. The stock appreciation right vests in three equal installments based on National Fuel Gas Company's satisfaction of a performance criterion for each of the fiscal years ending September 30, 2009, 2010 and 2011. The performance criterion for fiscal 2011 was met, resulting in vesting of the stock appreciation right as to 50,000 shares on December 22, 2011.
