On January 10, 2013 Wells Fargo assigned certain preferred class voting rights on all 50 shares of VMTP acquired by Wells Fargo on such date to a voting trust (the "Voting Trust") created pursuant to the Voting Trust Agreement, dated January 10, 2013 among Wells Fargo, Lord Securities Corporation, as trustee (the "Voting Trustee") and Institutional Shareholder Services Inc. (the "Voting Consultant"). Voting and consent rights on the VMTP not assigned to the Voting Trust have been retained by Wells Fargo. The Voting Trust provides that with respect to voting or consent matters relating to the voting rights assigned to the Voting Trust, the Voting Consultant analyzes such voting or consent matters and makes a recommendation to the Voting Trustee on voting or consenting. The Voting Trustee is obligated to follow any such recommendations of the Voting Consultant when providing a vote or consent. The 50 shares of VMTP acquired by Wells Fargo on January 30, 2013 are subject to the foregoing voting arrangement.
