Item 1.01 Entry into a Material Definitive Agreement.

On August 24, 2015, UDR, Inc., a Maryland corporation (the "Company"), closed the underwritten public offering (the "Offering") of 2,900,000 shares (the "Shares") of the Company's common stock, par value \$0.01 per share (the "Common Stock"), pursuant to an Underwriting Agreement dated August 19, 2015, between the Company and Credit Suisse Securities (USA) LLC (the "Underwriter"), a copy of which is filed herewith as Exhibit 1.1 and incorporated herein by reference (the "Underwriting Agreement"). Pursuant to the Underwriting Agreement, the Underwriter purchased the Shares from the Company at a purchase price of \$35.00 per share of Common Stock. As part of the Offering, the Company also granted the Underwriter a 30-day option to purchase up to an additional 435,000 shares of Common Stock.

Pursuant to the Underwriting Agreement, subject to certain exceptions, the Company, its directors and certain of its officers have agreed not to sell or otherwise dispose of any of the Common Stock held by them for a period ending 30 days after the date of the Underwriting Agreement without first obtaining the written consent of the Underwriter. Morrison & Foerster LLP, as counsel to the Company, has issued its opinion with respect to the legality of the Shares issued pursuant to the Underwriting Agreement and with respect to certain U.S. federal income tax matters, which opinions are attached hereto and incorporated herein by reference as Exhibits 5.1 and 8.1, respectively. Kutak Rock LLP has issued its opinion with respect to certain U.S. federal income tax matters, which opinion is attached hereto and incorporated herein by reference as Exhibit 8.2.
