- (1) On September 11, 2007 PACCAR declared a stock dividend of one additional share of common stock for every two shares of common stock payable October 9, 2007 to all holders of record of common stock on September 25, 2007. Number of derivative securities, underlying securities and price were adjusted to reflect 50% stock dividend. On December 7, 2007 the post dividend number of shares was erroneously reported as 31,090 (which was the pre-dividend number of shares); the correct post dividend number of shares is 46,635.
