- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 887 units were acquired at prices ranging from \$56.92 to \$63.40. These transactions are exempt under rule 16a-11.
- (2) Represents phantom units acquired by the reporting person (in an exempt transaction) as deferred compensation pursuant to the Partnership's omnibus plan. Each phantom unit is the economic equivalent of one limited partner unit in Cedar Fair, L.P.

- (4) During the fiscal year, 143 units were accrued on these phantom units as a result of distribution reinvestment.
