"Disclosure under s 198 - 212 Companies Act

Please find notification pursuant to Section 198 of the Companies Act 1985, that as at 21<sup>st</sup> March 2003, Old Mutual Plc and its direct and indirect subsidiaries had a material interest in 120,425,765 ordinary shares of BHP Billiton plc, representing 4.88% of the issued share capital. The shares are registered as per the attached schedule.

Although the disclosure concerns the position as at close of business on Friday 21<sup>st</sup> March, please note that a net increase in holdings by Old Mutual Asset Managers (South Africa) (Pty) Ltd (on behalf of its clients) of 23,270,300 on 17<sup>th</sup> March 2003 took Old Mutual Plc's aggregate holdings above 4%."
